## EXHIBIT RENTAL AGREEMENT FOR THE CONSTRUCTION SHOWCASE OF MAINE

Witnesseth that in consideration of the mutual agreements herein contained and subject to the conditions hereinafter expressed:

The Rentor (Nawic Maine Chapter 276) hereby rents to the Exhibitor (your company as noted on the receipt) the right to use exhibit space allotted in the show building and grounds for the period of 3:00 pm April 10, 2018 through 10:00 pm April 11, 2018. Exhibitor agrees to set up their display according to the schedule agreed upon, with setup completed prior to show hours, and will be completely moved out by 10:00 pm on April 11, 2018.

This agreement is subject to the rules and regulations as noted below and those of the Augusta Civic Center, both made part of this agreement.

The Exhibitor agrees to use the space outlined above for the purpose of promoting services and displaying products.

**These Rules and regulations become part of the *Exhibitor space Rental Agreement for the Construction Showcase of Maine*.**

### **LIABILITY:**

The Lessor (NAWIC Chapter 276) agrees to furnish Public Liability and Property Damage Insurance. Each Lessee (Exhibitor) also agrees to furnish Public Liability and Property Damage Insurance. Limits: \$300,000 Property damage and \$300,000 Bodily Injury. A Certificate of Insurance shall be furnished to the Lessor prior to setting up at the Augusta Civic Center. **NAWIC Maine Chapter 276, 60 Western Ave, Suite 3, Box 354, Augusta, ME 04330 must be listed as certificate holder.**

### **CARE OF BUILDING AND EQUIPMENT:**

Lessees, or their agents, must not injure or deface the walls or floors of the building and adjacent areas, including outside surfaces. If such damage appears, the Lessee is liable to the City of Augusta and the Lessor for the property so damaged. **All trash must be cleared and disposed of properly in accordance with Augusta Civic Center requirements so as to avoid additional charges.**

### **FIRE RULES AND REGULATIONS:**

Combustible exhibit and display materials inside the Augusta Civic Center must be flame-proofed. Vehicles may not be operated on the premises during show hours. Gas tanks must be approximately one-fourth full of gas. Tank openings must have a secure cap and be taped to prevent fumes from escaping. Battery cables must be disconnected and taped to prevent contact. All rules and regulations relative to public buildings as prescribed by the City of Augusta Fire Department must be adhered to.

### **LICENSES:**

The Lessee shall procure, at its own cost and expense, any license and official permits necessary for the purpose of displaying and exhibiting merchandise at the show.

### **GENERAL RULES:**

Lessee shall not, without prior written consent of the Lessor, assign or sublet such space, or any part thereof. The actual occupation of the space with the above exhibit is of the essence hereof. In the event the Lessee shall not occupy said space according to setup schedule, then, and in such event, the Lessor is expressly authorized to occupy or cause said space to be occupied in such manner as it may deem best for the interest of said show without any rebate or allowance whatsoever to s/Lessee and without any way releasing the Lessee for any liability hereunder, and the Lessee expressly agrees to pay Lessor the full sum herein above set forth.

The Lessor Assumes no risk, and by the acceptance of this agreement, the Lessee expressly release Lessor of and from all liability for any damage, injury or loss to any person or goods which may arise from the use or occupation of said space of Lessee and agrees to hold and save Lessor harmless of and fro any loss and damage by reason thereof.

No loud speakers or microphones will be permitted in booths. No food may be brought into the Civic Center, including complimentary popcorn, hot dogs, and/or any other giveaway food.

**CANCELLATION:**

Cancellation of space must be in writing and received by Lessor 30 days prior to the show. In the event such cancelation is received by Lessor 30 days prior to the show, all but \$100.00 (one hundred dollars) deposit per booth shall be refunded.

**FORFEITURE UPON DEFAULT:**

In the case of failure of lessee to make any of the payments, or any part thereof, or to perform or observe all of the conditions, covenants, and restrictions herein set forth, this contract shall, at the operations of the Lessor, be extinguished, and Lessee shall forfeit all payments made on the Agreement, and such payments shall, with or without notice of demand of any kind, be retained by Lessor as partial satisfaction of all damages sustained.

**AMENDMENTS:**

These Rules, regulations and show conditions have been drawn for the purpose of providing a well-balanced, well-regulated attractive and successful show. The Lessor shall have full power to interpret the rules and regulations or to make such and any and all amendments of the forgoing rules, regulations and conditions such bind the lessee. NO EXCLUSIVE OR VERBAL CONTRACTS will be recognized without written approval of the Lessor.
